







Municipalities should locate and secure disaster debris management sites prior to the occurrence of a disaster debrisgenerating event.



Secure and maintain pre-disaster debris management contracts with waste/recycling haulers, equipment, suppliers, etc. prior to the occurrence of a disaster debris-generating event.



Information should then be compiled into a formal plan.
